In memoriam

Pablo Azcue (1959-2024)



Pablo Azcue was a beloved Full Research Professor at our University and the Director of the Department of Mathematics and Statistics. He completed his undergraduate studies at the University of Buenos Aires and later earned his Ph.D. in Mathematics from Harvard University. He subsequently pursued postdoctoral studies at the International Centre for Theoretical Physics in Italy. He joined Di Tella as a professor in 1993, and four years later, he was appointed Director of the Department of Mathematics and Statistics, a position he held until his decease.

His excellence in research led to publications in prestigious journals such as *Mathematical Finance*, *Annals of Applied Probability*, *SIAM Journal on Control and Optimization*, *Mathematical Methods of Operations Research*, and *Insurance: Mathematics and Economics*. He co-authored the book *Stochastic Optimization in Insurance: A Dynamic Programming Approach* with Professor Nora Muler, which is part of the esteemed SpringerBriefs in Quantitative Finance series.

Besides being a distinguished educator, Pablo was known for his thoughtfulness and willingness to help everyone. In fact, in 2021, during the pandemic, he was honored with the La Dicha de los Comunes award for his significant contributions to public goods for the institution, particularly for his leadership in a discipline that initially seemed so challenging to teach virtually. We will always remember Pablo with immense affection and gratitude.

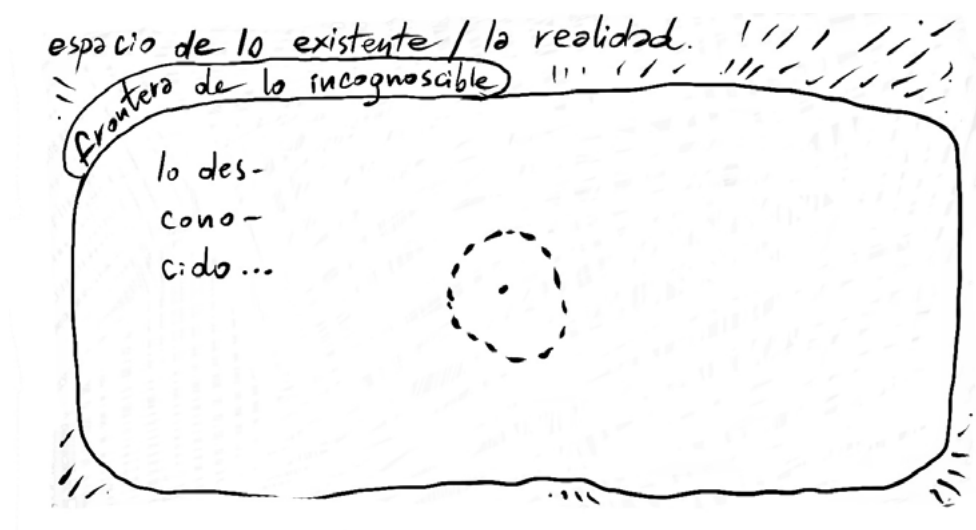

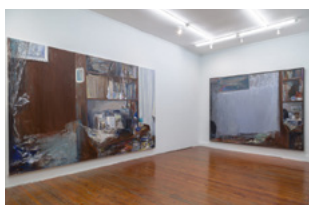
